### ECONOMIC SECURITY

At \$51,633, the median household income was slightly lower than the state median of \$51,704.

39.6% of public school students were approved for School Meals Programs, a 16% increase since 2000.

Orange County 3SquaresVT (food stamp) benefit enrollment of 15.3% is about the same as the state average of 15.7%.

Rates of 3SquaresVT enrollments and students approved for School Meals have both increased since 2000—which may be related to increased child poverty as well as improved outreach.

45% of children were enrolled in Dr. Dynasaur/Medicaid, slightly higher than the state average of 43.2%.

With the exception of poverty, median income estimates, and school meals, all rates and counts are based on three-year averages. For example, the year 2008 represents the average of 2006-2008.

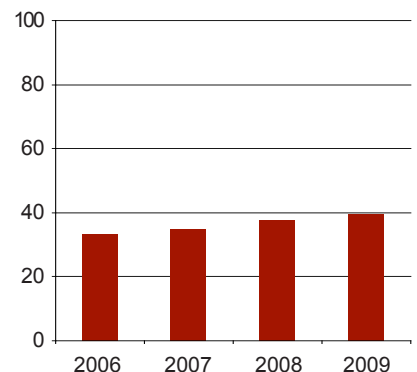

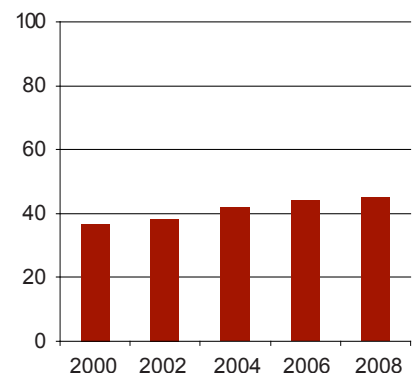

Percent of Students Approved for Federal School Meals

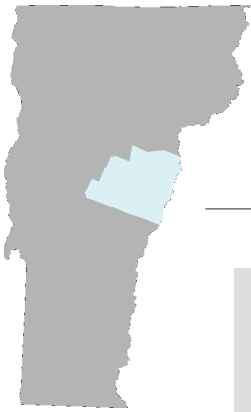


Percent of Children Enrolled in Dr. Dynasaur/Medicaid

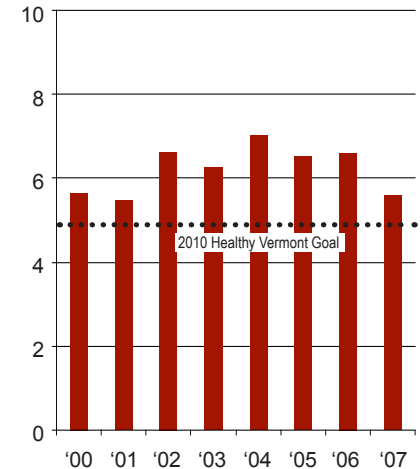

### HEALTH

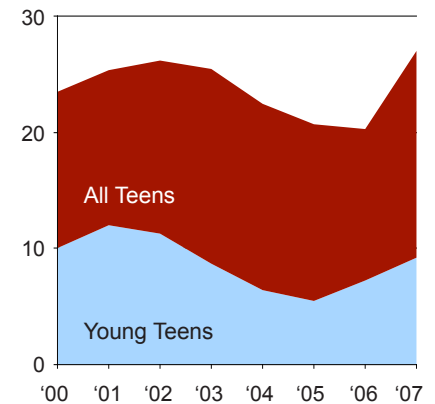
Between 2000 and 2008, the number of children in Orange County declined by 16%. During that same time period, the state child population declined by 11%.

Babies with low birth weight—under 5.5 pounds—are at risk of respiratory conditions, cognitive and developmental delays, and long-term conditions. Our *Healthy Vermonters 2010* goal is to reduce the percentage of low birth weight babies to 5.0%. Orange County's rate is holding steady at 5.6% of all live births, the same as in 2000.

Teen birth rates were 27.0 per 1,000 teen girls aged 15-19, 15% higher than in 2000.

The percent of pregnant women receiving prenatal care within the first trimester was 83.7%, short of the *Healthy Vermonters 2010* goal of 90%.

Births to Teens and Young Teens per 1,000 Births



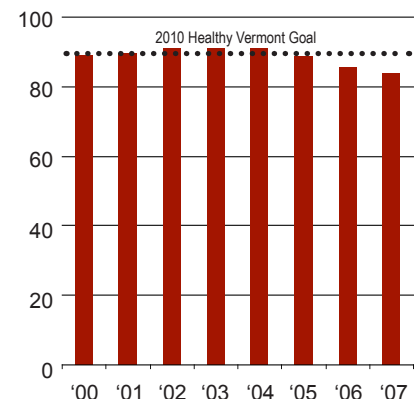

For example, the year 2008 represents the average of 2006-2008. Rates based on small counts should be used with caution. Such rates may change significantly from one period to the next—even if the actual count only increased from 1 to 2.
