ECONOMIC SECURITY

At \$51,338, the median household income was slightly lower than the state median of \$51,704.

Participation in School Meals Programs grew by 51% between 2000 and 2009, from 24.8% to 37.4%.

14.8% of children received 3SquaresVT (food stamp) benefits, slightly lower than the state average of 15.7%.

Rates of 3SquaresVT enrollments and students approved for School Meals have both increased significantly since 2000—which may be related to increased child poverty as well as improved outreach.

41.9% of the county's child population is enrolled in Dr. Dynasaur/Medicaid, slightly less than the state average of 43.4%.

With the exception of poverty, median income estimates, and school meals, all rates and counts are based on three-year averages. For example, the year 2008 represents the average of 2006-2008.

² Since the estimates are not based on direct counts, county data should not be compared. Smaller population areas have wider confidence intervals and should be used with caution. 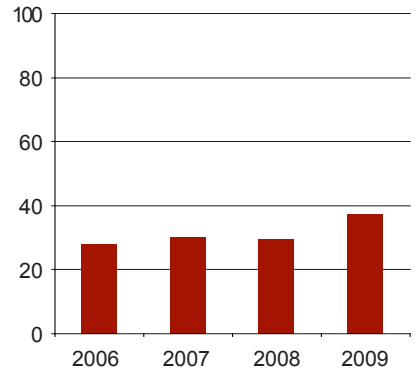

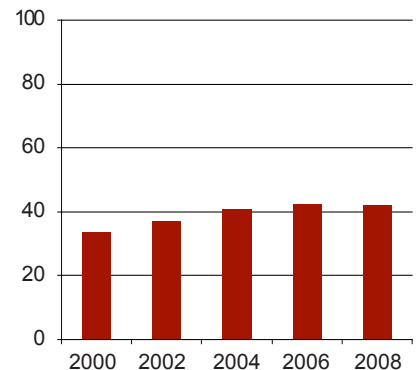

Percent of Students Approved for Federal School Meals

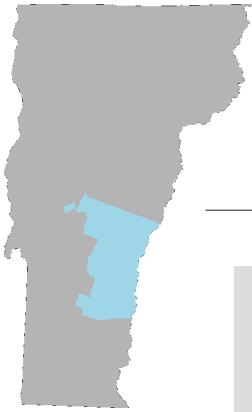


Percent of Children Enrolled in Dr. Dynasaur/Medicaid

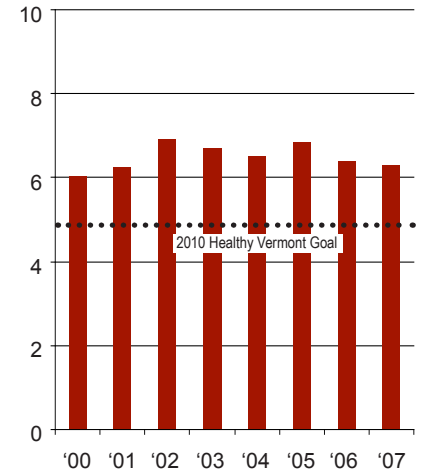

HEALTH

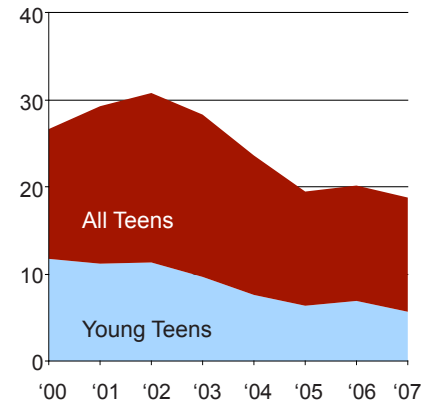
Between 2000 and 2008, the number of children in Windsor County declined by 16%. During that same time period, the state child population declined by 11%.

Babies with low birth weight—under 5.5 pounds—are at risk of respiratory conditions, cognitive and developmental delays, and long-term conditions. Our *Healthy Vermonters 2010* goal is to reduce the percentage of low birth weight babies to 5.0%. Windsor County's rate is 6.3% of all live births, up slightly from 6.0% in 2000.

Teen birth rates were 18.8 per 1,000 teen girls aged 15-19, which is about 30% lower than in 2000.

The percent of pregnant women receiving prenatal care within the first trimester was 81.7%, compared to the *Healthy Vermonters 2010* goal of 90%.

Births to Teens and Young Teens per 1000 Births



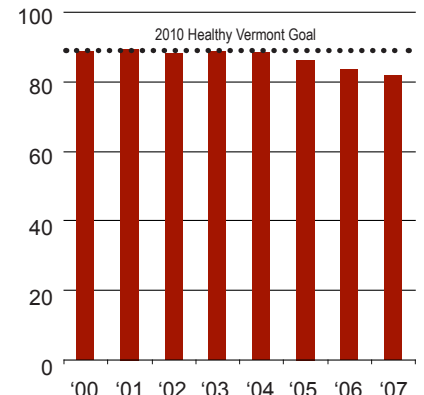
